**WHITE MONEY CLUB (WMC) MEMBERSHIP TERMS & CONDITIONS**

In view of the above, thus the following terms & conditions for White Money Club Members binding to members are as under:-

1. That White Money Club Membership (hereinafter called WMC Membership) shall be for the period of four years for every person or member from the date of registration of membership by him, at the sole discretion of White Money Club and its Chairman.
2. That "White Money" and "Legal Money" means the money which is provided by the Banks, Financial Companies and Institutions etc. as per all Law, Rules and restrictions applicable, it does not mean that the White Money Club is acting, working and functioning as an Bank and Financial Institute or Company as the services, advice, consultancy being given by the White Money Club is only in the nature of help, assist, consult and advice to members to save their "White Money" or "Legal Money" as per Law & Rules and Bank & Financial Systems prevailing and applicable in India. The White Money Club therefore is of in the nature of charitable trust or society for the welfare of the people in respect of the aims, objects and subjects as designed and given in the website of White Money Club i.e. [www.wmclub.in](http://www.wmclub.in) or [www.whitemoney-club.com](http://www.whitemoney-club.com).
3. That at the time of registration as White Money Club Membership by the person, individual, company, firm, IAS, IPS, IFS, IRS and their family members and all others who joint or register as member of White Money Club is require to pay rupees four thousand as maintenance cost & expenses then only person or member is/are eligible to join and continue for four years as member of White Money Club. The expenses and maintenance cost may be paid online & offline by cheque, DD, pay order as per law. The amount of rupees four thousand paid towards expenses and maintenance shall not be refundable by White Money Club under any circumstances for which the person or member who join is/are fully agree and give his undertaking not to claim the amount of expenses and maintenance from White Money Club in every manner or by any proceedings and if any comes the same shall be void.
4. That, all the members, person, company, firm etc. who join as member of White Money Club are factually and legally bound with privacy policy, user agreement and all other terms and conditions of White Money Club as given and designed in the White Money

Club website called [www.wmclub.in](http://www.wmclub.in) or [www.whitemoney-club.com](http://www.whitemoney-club.com) and added, amended, altered, imposed from time to time without any notice to any member of White Money.

5. That the continuation and discontinuation of any membership (which is free) will be at will and sole discretion of the Chairman of White Money Club.
6. That all persons or members of White Money Club who join or intended to join are undertakes himself/them-self not to harm, damage, disrepute, destroy the goodwill and reputation of White Money Club and will not do any act and conduct to make any loss and damage the White Money Club in any manner factually, economically, socially and financially.
7. That all persons or members of White Money Club who join or intended to join declare that the information, facts, details given by them and the time of joining, login, registration as White Money Club member are true & correct and nothing has been suppressed by them and if any such information found incorrect, false and untrue, their names will be deleted and removed automatically as member of White Money Club without any notice and hearing and in such a situation it will be deemed that such member or person has/have resigned from membership of White Money Club. In such a situation, a member will not be entitled to login and use the facilities and services of White Money Club.
8. That the White Money Club, constituted on AOP have decided to fix the total numbers of members on All India Basis i.e. three crore, which can be extended at the sole decision of White Money Club if confirmed by the Chairman of White Money Club. It means the sole decision of Chairman in this respect will be binding to White Money Club and all.
9. That the White Money Club act as an intermediate portal to facilitate its members to build their "White Money" or "Legal Money" as per law and terms and conditions, therefore the services being given to the members are intermediate, thus there is no assurance and guarantee to any members that they will receive and get "White Money" or "Legal Money" from White Money Club and from others. Therefore no persons or members who joined or intended to join is/are legally and factually not entitled for "White Money" or "Legal Money" directly from White Money Club. However any member is/are entitled to build the "White Money" or "Legal Money" as per law and

rules from Banks & Financial Institute etc. with the intermediate help and advice of White Money Club due being member of White Money Club, the intermediate portal and services which are free for members subject to terms and conditions stated above and given in the website of White Money Club i.e. [www.wmclub.in](http://www.wmclub.in) or [www.whitemoney-club.com](http://www.whitemoney-club.com) and as amended from time to time.

10. If any disputes arising out of the any terms and conditions and any other matter between White Money Club and any members, the same shall be referred to a sole Arbitrator duly appointed by the Learned Court within the jurisdiction District Jabalpur and the place of Arbitration Proceedings, Award and Decision will be at Jabalpur (M.P.) only. Award and decision will be binding to the parties or White Money Club and members.
11. That all or any member of White Money Club is/are bound to follow the instructions, advice, guidelines, issued and served by White Money Club from time to time for the purpose of building the "White Money" and "Legal Money" in favor of the members of White Money Club as the White Money Club is acting and working as intermediate portal and services between members and financiers or banks and working and acting in the welfare of people, to promote digital economy and payments, education, health, as per aims and object of White Money Club designed and given in the website [www.wmclub.in](http://www.wmclub.in) or [www.whitemoney-club.com](http://www.whitemoney-club.com).
12. That White Money Club does not support and promote the "Black Money" in any manner and is deadly against Black Money, therefore the White Money Club has been constituted to promote and support the "White Money" or "Legal Money" and Digital Economy and Payments etc. as designed and given in [www.wmclub.in](http://www.wmclub.in) or [www.whitemoney-club.com](http://www.whitemoney-club.com).
13. That White Money Club memberships are fixed to the tune of three crore members on all India basis on payment of expanses and maintenance charges as stated above by each member in the individual account of the chairman of white money club being received with consent of the person or member who is joining white money club as terms, conditions of white money club. However such expanses and maintenance charges shall be received in future on opening of bank account in the name of white money club which has been applied.

14. That the services and membership of white money club shall be commenced with effect from 1.4.2017 and later on the date of joining whichever is applicable for the period of four years as per terms which can be renewed by members under fresh terms & condition of white money club if any at the discretion of white money club.
15. That "White Money Club" has been constituted to give free services, advice & help to its members only who join "White Money Club" online by login [www.wmclub.in](http://www.wmclub.in) or [www.whitemoney-club.com](http://www.whitemoney-club.com) to receive advice, consultancy from us by them to create, obtain and save their "White Money" or "Legal Money" in accordance with law, rules & in legal manner to utilize it for the above said purposes, need, requirement by members of "White Money Club" (WMC). White money or Legal money means personal loan, Business loan, Credit card, Home loan, Wallet, Loan against property, Mutual fund, Car loan, Fixed deposit, Insurance, Saving account, Education loan and Gold loan etc. created, obtained or saved by members of white money club through banks and financial institutes as per law and rules on advice, consultancy and help of white money club for which it has been constituted for members who join for such things, facilities and advice.
16. That white money club do not take or receive expenses or maintenance charges in cash, such expenses or maintenance aforesaid is/are payable only by online, cheque, DD, pay order and by digital payments, therefore if any payment made in cash to any of the person, company, firm etc. for joining WMClub to any agent, representative, employees, person, the white money club will not be responsible in any manner for any losses or damages.
17. The foresaid payment of expenses or maintenance of rupees four thousand aforesaid can be treated as fee or charges for advice or consultancy by white money club for which the person who is joining as member has/have no objection and claim in any manner in future.
18. On joining minimum five thousand members, the services and functions of WMClub will be started.
